SO.02-Addressing the key challenges of ageing workforce: the role of job security and work-life balance

The ageing workforce is a complex phenomenon profoundly affecting societies, labor markets, political systems, and cultural norms. Researchers, health professionals, and policymakers urgently need comprehensive knowledge about the various facets of the ageing process to address the social and demographic challenges faced in Europe and worldwide. This knowledge is essential to foster healthy, active, productive, and sustainable ageing among workers. This session aims to gather contributions focusing on the ageing process, specifically exploring the relationship between ageing, job security, and work-life balance, with a focus on the territorial dimension. The track welcomes studies that examine predictors, moderators, and outcomes of job security and work-life balance across different levels (e.g., individual, organizational, societal), along with their interaction mechanisms. Studies exploring the temporal micro- and macro-dynamics of job security and work-life balance are also encouraged. Submissions are invited from various fields, including economics, sociology, and management, encompassing both theoretical and empirical (qualitative or quantitative) works. The overarching goal is to provide opportunities to communicate and share valuable knowledge for handling the ageing process and driving policy changes that benefit older workers at local and global levels, promoting their human development, well-being, and quality of life.
