Laurent Carnis is a senior Researcher at University Gustave Eiffel. His fields of research deal with public policy analysis, governance and evaluation of road safety policies from an economic point of view. He is also an expert with international organizations (Piarc and Irtad). He is a member of Mosar (research federation) at University Gustave Eiffel.

Ayman Zoubir is an urban planner and holds a Ph.D. in urban studies. He applies a multi-disciplinary engineering approach to transportation and urban mobility issues on which he has been working for more than 10 years. He currently works at Cerema as responsible of projects in the fields of mobility and road safety.

In his presentation, Ayman Zoubir will show that understanding crash patterns and addressing safety challenges remains crucial for county councils as road managers of 380,000 km of local roads network. To characterize the road safety policies carried out by county councils and identify measures are a key input for reducing crash frequency and severity. The intervention considers the diversity of territories (geographical, demographic, economic, etc.) and road safety policies to highlight these issues.

David Swan obtained a PhD in economics from Lyon II University in 2023. His thesis covered the estimation of social benefits created by fire and rescue services, focusing notably on the cause-to-effect relationship between their actions and different socio-economic outcomes. He is currently a post-doctoral research fellow at Gustave Eiffel University, analysing the organisational response to road-traffic accidents in France.

Master degree "Maritime Economics and Coastal Development". Alexandra works on migration, residential mobility, urban growth and quantitative economics.

In his presentation, **David Swan** will discuss the efficiency of fire and rescue services in France. Indeed, there is a general consensus that greater spending on fire and rescue services does not lead to better outcomes (fewer fire deaths). This work examines the veracity of these claims using detailed expenditure data at the county-level across France from 2012 to 2019.
